## INSTRUCTIONS

By completing this application, you are requesting an evaluation to determine your eligibility to participate in the TVA EnergyRight® Home Uplift program. To qualify for the program the home must:

- be on a permanent foundation
- built after 1976
- not have received upgrades from similar TVA funded pilot projects/programs within 20 years
- be owner occupied
- meet income eligibility
- have an energy evaluation performed

Eligibility is based on the total combined income for all household members over the age of 18 living at the home.
